In reference to your application for Renewal of registration as a System Integrator for implementing Off-Grid Decentralized Solar Photovoltaic (SPV) projects under Market Mode scheme of CREDA for Financial Year 2020-21 anywhere in Chhattisgarh State, your registration is hereby considered for renewal as System Integrator (SI) for installation of SPV systems under "Category C (01 kWp - 100 kWp) vide reg. no...7.1.....8../CREDA/SPV/Off-Grid/2020/Dated OSFP 21 as per following terms and conditions:-

- 1. Under stated category, you have to install SPV Off-grid systems of minimum 100 kWp aggregate capacity during this current year, failing which you will not be considered for renewal as SI for next year.
- 2. Your registration is valid up to **03-07-2021** however all terms & condition of the market mode scheme of CREDA for FY 2020-21 (31.03.2021) shall be applicable. In case of any change in policy due to change in Financial year/otherwise, the same will be applicable to this registration.
- 3. System Integrators should associate themselves in creating awareness and educate end users / potential beneficiaries in order to promote use of renewable energy. System Integrators shall not use either CREDA's logo or any other Central / State Govt. departments' logo on any of their pamphlets, advertisement, publication, websites, etc.
- 4. The SIs registered with CREDA is an associates ONLY. They are not directly or indirectly official / integral part of CREDA. Their registration with CREDA does not entitle them to be eligible for any Govt. work. The eligibility of SI for any Govt. work is adjusted by CREDA on case to case basis.
- 5. SI's are not entitled to quote/produce rates or work directly to any other Govt. departments/Agency. (Including PSUs, Gram Panchayats, Municipal Corporations, JFMs, SHGs, CSR funds etc.) Any System Integrator found violating these norms will not only be blacklisted and debarred from CREDA but also a suitable legal action shall be taken and his/their EMD will also be forfeited.
- 6. The guidelines, formats for application for subsidy and Joint Commissioning Certificate (JCC) etc are already uploaded in CREDA Website i.e.http://creda.cgstate.gov.in. All SI's are instructed to follow the same.
- 7. CREDA reserves the right to modify/cancel/reject any registration without giving any reasons or prior notice.
