## **GST** is Happening. Be Prepared Now!

GST is an indirect tax that may affect all inputs and outputs of a business organization and this tax will replace the existing sales and services tax regime. To ensure you are GST ready, a coordinated effort within the business organization is essential. It is just not another tax issue to be left only with the Finance and Accounts Department. Rather, it is a "cross functional" issue that can affect the entire business structure and hence require input from all key business units.

GST is a multi-stage tax, which means the Government collects the tax at various stages along the delivery process. Although paid by the intermediaries (such as manufacturers, wholesalers and retailers) throughout the production and distribution chain, the tax is ultimately passed to the consumer. Therefore,

the tax is not a cost to the intermediaries and is not reflected in their financial statements as expenditure.

A business registered in the GST system is required to charge GST on its output of taxable goods or services supplied to customers. The business is allowed to claim as credit any GST incurred on its purchases of business inputs. The customers, if they are also making taxable supply of goods and services, in turn, are allowed to claim a credit on GST paid on their inputs. Thus, double taxation is avoided and only the value added at each stage is taxed.
